## 1. Welcome

- 2. Presentations
  - 169 pavement and bridge repair in the City of Jordan area Diane Langenbach, MnDOT
    - o Includes significant signage of detours in area
    - o Is occurring along with downtown reconstruction in Jordan
    - Has affected area businesses
  - 169 flood mitigation to raise grade one foot above 100 year flood plain Peter Harff, MnDOT
    - o Using R-cuts
    - o Includes the building of another bridge
    - o Road will be completely closed
    - Region 9 Development Commission wrote the grant that awarded \$9.8M
    - 9-miles of concrete construction, want to get this done in one season with closure
    - Hwy 99 bride construction planned for 2017

3. Adoption of Agenda

Member Gates moves to adopt the agenda. Commissioner Stuehrenberg seconds the motion and it is approved.

4. Adoption of January Minutes

Member Wille moves to approve the minutes. Councilman Lehman seconds the motion and it passes.

- 5. Financial Report
  - WSB joined at the \$1,000 level
  - Cash balance of \$141,792.95
  - Coalition agreed to pay \$25,000 for transitway study, will be invoiced by Scott County
  - Intercity bus study will be included
  - Were able to get District 7 engaged with a \$50,000 contribution
  - Councilman Lehman motions to approve the report. Member Gates seconds the motion and it passes
- 6. 169 Transitway Study
  - Market feasibility for long haul service will be a component
  - Received 5 proposals, SRF consultant selected; In process of developing work program
  - Study will kick off in late June; detailed alternatives will be selected in February 2016; locally preferred alternative recommendation in August 2016
  - Can be done in increments rather than a big project at once
  - The 169 corridor was one of the highest performing corridors in the MnDOT study (presented by Cole Hiniker)
  - MVTA
    - Looking at fixed route service in northern Scott County, City of Savage, City of Prior Lake, and the City of Shakopee; will fit well into transitway study
- **7.** Scott County Sales Tax
  - Scott County approved a 0.75% sales tax for 7 years to generate \$6M revenue for transportation projects and transportation operations/capital
  - Projects will focus on inter-regional corridors and principal arterials
  - Have identified some recommended projects in the County

- 8. TIGER Support Request
  - Councilman Lehman makes a motion to approve the TIGER Grant support letter from the Coalition. Commissioner Stuehrenberg seconds the motion and it is approved
- 9. Upcoming Meetings
  - Next Executive Committee meeting will be in August
  - Next full Board meeting will be on September 17<sup>th</sup>
    - Will include SW LRT update
    - City of Savage Scoping Study and CVA Grant update presentation
