






With this gap completed there will be a continuous 4.3-mile local road connection from the Bluff Drive industrial area to the City of Jordan.

Major agricultural access point. Project removes direct accesses to TH 169, including "World's Largest Candy Store".

TH 169 & Bluff Drive Overpass

PROJECT DESCRIPTION:

Hybrid Interchange with overpass and improved access to TH 169 at 166th street that includes acceleration lanes and turn lanes to support heavy truck volumes.

PROJECT COST:

Total Project Cost: \$14 Million

State Legislative Funding Request: \$4.6 Million

Funding request will assist in upgrading existing roads. Additional funding, if secured, will allow an additional project to remove the TH 169/ Jordan Ave connection and extension of Jordan Ave to 173rd street. With this gap completed there will be a continuous 4.3-mile local road connection from the Bluff Drive industrial area to the City of Jordan.

TH 169 & Hwy 282/CSAH 9

PROJECT DESCRIPTION:

TH 169/TH 282 Interchange Project is a gradeseparated interchange eliminating the last traffic signal within 50 miles of the Twin Cities on TH 169 and grade separating CSAH 9 over a Union Pacific Railroad. Innovative interchange design improves operations for all modes of travel.

PROJECT COST:

Total Project Cost: \$47.2M

TH 169 & CSAH 59/

Delaware Ave. Interchange

PROJECT DESCRIPTION:

The TH 169 & CSAH 59 Interchange Project will create a Folded Diamond Interchange with pedestrian accommodations. The project includes frontage road connections that will remove direct access to TH 169 for several high traffic businesses including the World's Largest Candy Store.

PROJECT COST:

Total Project Cost: \$22.3 Million

• State Legislative Funding Request: \$2.5 Million

Currently this project is being funded 100% by Scott County. The requested state funds will assist with funding gap for frontage road improvements required for the project.
